

ACCESS AND STAY RULES

for our best friends

1. By entering with your pet, you accept and commit to respect these rules.
2. Access with your pet only to premises identified as "Pet friendly". If you have doubts, consult with the establishment, our website, or the Information Point.
3. Your pet must always be with you on a leash and never loose, especially in dining areas.
4. Pets are not allowed to get onto the Centre's furniture, nor are they allowed to be left tied up alone at any point.
5. Prevent your pet from relieving itself inside. If you cannot prevent it, proceed to collect and clean it up. Please notify our cleaning or security service so that the area can be disinfected.
6. For the safety of your pet, always use the lifts. The use of escalators and moving walkways is prohibited.
7. As the owner, you are solely responsible for the behavior and custody of your pet during the visit.
8. You must comply at all times with current regulations on animal welfare (municipal, regional, and state).
9. Avoid coming with your pet if it is a female in heat, as this cycle can alter the behavior of another female or male found on the premises. The same precaution applies if your pet does not have its vaccinations and/or deworming complete, as it could harm other animals found on the Shopping Centre premises.
10. The access of pets to bathrooms, breastfeeding rooms, and children's areas is prohibited (except for assistance dogs).
11. The Centre's staff cannot watch over or look after pets.
12. Only one pet per person is allowed.
13. ànecblau Shopping Centre is not responsible for incidents arising from access with pets; civil liability rests with the owner.
14. We reserve the right to limit access due to crowds, safety, or to modify these rules.
15. By accessing the Shopping Centre, the keeper of the animal assumes absolute guardianship, custody, and responsibility for it, and consequently, you will assume any liability derived from the behavior of the animal, expressly exempting the Owner of the ànecblau Shopping Centre, as well as its managers and employees, from any material and non-material damages that your pet may cause during its stay in the Shopping Centre.
16. The keeper and/or owner of the animal, as applicable, will assume the civil, administrative, and/or criminal liability derived from the possession or ownership of the animal itself and/or from the behavior of the animal, and will hold the Owner of the ànecblau Shopping Centre, its managers, and employees completely harmless from any judicial or extrajudicial claim presented for these facts, with the keeper and/or owner of the animal expressly assuming compensation for any damages that may take place, which would include, in any case, the payment of the costs incurred for the proper defense of the matter.
17. ànecblau Shopping Centre reserves the right of admission for any pet whose behavior affects the normal and peaceful stay of visitors in the Shopping Centre.
18. All these rules will be applicable both on the commercial floors, as well as in the underground parking and the outdoor spaces of the Centre.
19. ànecblau Shopping Centre reserves the right to modify these general rules for the access and stay of pets, at any time, in accordance with the policies and protocols considered most appropriate for the safety and health of visitors.
